SpecialNote:

1. No application/fee will be accepted after the date as mentioned in the above advertisement. The applicant will be able to printout this application after his/her fee is adjusted by the bank. Therefore, the fee from the bank should be mandatorily adjusted by the candidate. Candidate can also amend his application form before final submission, except –his/her Registered Mobile Number, Email, Aadhaar Number, Category, etc. **Candidates are advised to visit website www.pgich.edu.in for periodic update**
2. If any information provided by the candidate is found to be false at any stage of recruitment process or thereafter, the candidature of the candidate shall be summarily rejected.
3. Reservation is applicable only to the reserved category candidates having domicile of Uttar Pradesh only Rules regarding reservation of Uttar Pradesh state Government shall be applicable. Other state candidates under reserved category candidates may apply against unreserved vacancies.
4. The medium of test/exam will be **English language only.**

Information required for candidates applying online-Online application system is applicable for applying under the above advertisement. Application sent through any other means will not be accepted. Candidates should apply online only. Please ensure compliance with the procedure given below.

GENERAL INSTRUCTIONS

1. Aspiring applicants satisfying eligibility criteria in all respect can submit their ONLINE application only. On-line application (s) link is available on, website www.pgich.edu.in
2. Applicants must fulfill all essential eligibility criteria, educational qualification, age limit, etc. as per appended Guidelines.
3. The **application fees is not refundable in any circumstances and the amount is as under:-**

The candidates belonging to the other category (Horizontal) shall have to pay fee according to their original category.

4. On-line Registration and submission process schedule will start on 1st August 2024; Examination will be conducted according to the published schedule (shall be informed to eligible candidates). Candidates are advised to visit Institute's website for the detail schedule of the Examination.
5. As per Acts and GOs on Reservation of Government of Uttar Pradesh may change the number of reserved vacancies in accordance with the prescribed/policy directions in the Ordinances/Orders.
6. Reservation policy of the Uttar Pradesh state Government shall be applicable.
7. The Uttar Pradesh, Public Services, (Reservation for physically handicapped, dependent of freedom fighters and ex servicemen) Act 1993, dated 29.12.1993, and (Amendment) Act 2018 dated 01.09.2018 & (Amendment) Act 2021 vide Notification No. 450 (2/LXXIX-V-1-21-1-ka-12-21 Lucknow dated 10.03.2021 shall apply in the reservation under other category (i.e. Horizontal) and will be applicable only to the identified posts (in the Divyang category).
8. Before applying, candidates must read the mandatory qualifications (academic) and others prescribed for vacant posts and ensure that they hold the required mandatory qualification (educational & Professional) and other for the post and only those who are covered under the prescribed age limit can apply online.
9. It is mandatory for the candidate to tick(✓) the requested reservation category while registering; otherwise his/her application will not be accepted.
10. The number of vacancies mentioned in the above table may increase or decrease.
11. Age relaxation for SC/ST & OBC candidates up to a maximum period of 05 years, is applicable as per guidelines and relevant GOs of Govt of UP.
12. In case of Divyang / Disabled/ Handicapped candidates, the age relaxation is up to maximum period of 15 years (Ref. GO.NO. 18/1/2008-Ka/2/2008 Karmik-anubhag2 dated 03.02.2008 of Government of UP.
13. Relaxation in upper age limit in favor of Ex-serviceman will be as per U.P. Government rules which follows rules of Government of India.
14. No document including printed/ hard copy of online application forms are required to be sent by post. However, applicants are advised to keep one printed / hardcopy of their application forms.
15. The Test will be held at places as PGICH reserves the right to allocate any test city or change the test city opted by the candidate.
PGICH reserves the right to cancel any of the Examination City/Centre and/or add some other cities/centers depending upon the response, administrative feasibility or any force-majeure conditions etc.
16. Applicants in regular employment must submit a "NO OBJECTION CERTIFICATE" from employers.
17. Candidates with valid application shall be issued call letter and admit card. These can be downloaded by candidates directly from Institute's website www.pgich.edu.in by entering their registration number/application number and Date of birth. **Call letters/Admit cards will not be sent by post.** This facility would be available on website accordingly as per published schedule of examination.
18. No TA/DA shall be admissible for appearing in WrittenTest/SkillTest/Interview.

19. All Disputes/differences or litigations shall be subject to territorial jurisdiction of GB Nagar/ Allahabad Court only.
20. The number of posts may increase or decrease. Director PGICH reserves right to fill any or all of advertised posts or not to fill same without assigning any reason.

Age-Limit

- 1- The decisive date of age calculation for recruitment to all the posts mentioned in the above table is 1st July. Candidate has to have attained the age of 18 years and should not be more than 40 years age.
- 2- In case of candidates belonging to Scheduled Castes, Scheduled Tribes, OBCs and other such categories of candidates in Uttar Pradesh, the upper age limit will be as high as specified by the Government.
- 3- In case of Permanent Government Employees who have rendered not less than 3 years regular and continuous service in the relevant field is relaxable up to maximum period of 5 years as per GOs of Govt. of UP, Karmik Anubhag -4 Ref No. -2-E.M./2001-Ka-42013 dated 27.08.2013
- 4- For appointment on direct entry posts an ex-service man vide U.P.Govt Niyukti (kha) deptt. no. 5/1/66-niyukti (kha) dated 16.3.1970, he shall be allowed to deduct the period of his service in the armed forces from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post / service for which he seeks appointment by more than 03 years, he shall be deemed to satisfy the condition regarding the upper age limit. However, he should have rendered satisfactory approved military service in any wing of army, navy or air forces and he should be otherwise eligible for the post.

Reservation-

The Scheduled Tribes/Scheduled Castes/ Other Backward Castes (OBC) , EWS & other categories (i.e. horizontal) reservation will be admissible as per the periodic/ existing orders of the Government of Uttar Pradesh.

Horizontal reservation:

The Uttar Pradesh, Public Services, (Reservation for physically handicapped, dependent of freedom fighters and ex servicemen) Act 1993 , dated 29.12.1993 and(amendment) Act 2018 dated 01.09.2018 &(Amendment) Act 2021 vide Notification No. 450 (2/LXXIX-V-1-21-1-ka-12-21 Lucknow dated 10.03.2021 shall apply in the Horizontal reservation and will be applicable only to the identified posts (for Divyang category).

Essential Educational Qualification

For recruitment to all the vacant posts mentioned in the above Table-1, it is mandatory for the candidate to hold the following mandatory qualifications (educational and other preferential qualifications) as on 1st July, 2024 as per guidelines appended.
